#### **REGISTRATION AND CATEGORIZATION OF CONTRACTORS/SERVICE PROVIDERS**

## A. REGISTRATION REQUIREMENTS

### A.1 Petty Contractors/Service Providers

- (a) Evidence of Registration with Corporate Affairs Commission (CAC)
- (b) Tax Clearance Certificate/Evidence of payment of either the company or personal income tax of one Director for the immediate past year.
- (c) Evidence of Professional License/Certificate of Artisanship
- (d) Evidence of TIN Registration
- (e) Edo State Health Insurance Certificate/Card
- (f) Sworn affidavit affirming the correctness of all registration documents.

### A.2 Small and Medium Sized Enterprises (SMEs)

- (a) Evidence of Registration with Corporate Affairs Commission (CAC)
- (b) Tax Clearance Certificate/Evidence of payment of either the company or personal income tax of at least one Director for the immediate past year
- (c) Evidence of TIN Registration
- (d) Evidence of Professional License/Certificate of Artisanship
- (e) Bank statement of account for the immediate past three (3) months
- (f) Edo State Health Insurance Certificate/Card
- (g) Sworn affidavit affirming that the company is not in receivership, subject of any form of insolvency or bankruptcy proceedings, winding up petition, that none of the directors have been convicted of any offence in relation to financial impropriety and for the correctness of all registration documents.

### A.3 Other Limited Liability Companies (NON SMEs)

- a) Evidence of Registration/Incorporation with the Corporate Affairs Commission, including current Form Co 7-Particulars of Directors.
- b) Tax Clearance Certificate/Evidence of Payment of Taxes in the last three (3) years.
- c) Evidence of Professional License/Certificate of Artisanship to carry out the stated/specified service(s).
- d) Corporate/Company Profile of the firm, including CV of management and technical staff as well as evidence of their registration with relevant professional bodies.
- e) Company audited accounts in the last three (3) years.
- f) Evidence of projects executed in the last three (3) years.
- g) Evidence of VAT Registration and Remittance.
- h) Evidence of TIN Registration.
- i) Evidence of owned/hired relevant equipment
- j) Joint Ventures/Partnership Agreements.
- k) Edo State Health Insurance Certificate/Card
- Sworn affidavit affirming that the company is not in receivership, subject of any form of insolvency or bankruptcy proceedings, winding up petition, that none of the directors have been convicted for any offence in relation to financial impropriety and for the correctness of all registration documents.
